**Now this indenture witness as follows :-**

- 1- That, in order effectuate his aforesaid desire, the settler has set apart and handed over to the trustees, a sum of Rs. 10,000/-

(hereinafter called the "Trust Fund" which expression shall include cash and any other property or investments of any kind whatsoever into which the same or any part thereof might be converted, invested or varied from time to time or which may be acquired by the trustees or may come to their hands by virtue of these presents or by operation of law or otherwise. Howsoever in relation to these presents), and the trustees shall hold and stand posed of the same upon the Trust subject to the powers, provisions agreements declarations hereinafter contained.

- 2- That the name of trust shall be WING OF AGRICULTURE GLOBAL GREEN & SOCIAL SERVICES and its office, for the present, be situate Vill-Oriya Distt: Hazaribag Pin code :825301 India District Hazaribag, Jharkhand and/or at such other place or places as the trustees may decide from time to time.
